North Front Street utility project begins

A major project to improve two blocks in historic downtown Wilmington, and replace aging water and sewer infrastructure, is officially underway.

Construction on the City of Wilmington's North Front Street Streetscape Project kicked off April 18. The project will bring new utility services, pavement, sidewalks, lighting, landscaping, and street furnishings to North Front Street between Chestnut Street and Walnut Street. For our part, we'll be replacing 1,040 feet of sewer mains, 1,070 feet of water mains, and 8 sanitary sewer manholes. Some of the pipes to be replaced date to the 1940s and '50s and have reached the end of their useful life.

By partnering with the City to replace these lines at the same time as the streetscape improvements, CFPUA is reducing interruptions to our customers along North Front Street.

Rolling out messages about wipes, grease



You've probably seen CFPUA's Vactor trucks driving around Wilmington and New Hanover County. These trucks are important tools for keeping our wastewater systems moving; crews use them to clean out blockages from sewer mains.

Starting this month, we're adding important visual reminders to our trucks about the hazards of flushing wipes, cooking grease, and garbage. The trucks will also carry CFPUA's 24-hour emergency hotline, 910-332-6565, which customers should call if they spot a sewer spill.

Almost all the sewer blockages we respond to are caused by materials that have been improperly disposed of in the sewer system. When customers put fats, oils, and grease (FOG) down the sink or flush wipes and other trash down the toilet, it leads to nasty clogs in sewer mains. If the clogs get big enough, they can cause wastewater back-ups and even sewer spills.
