

### **CFPUA** receives \$35 million in State Budget

North Carolina's new State Budget is putting significant funding toward communities affected by PFAS contamination, including \$35 million to help CFPUA serve more people.

On September 22, N.C. General Assembly ratified the <u>2023 Appropriations Act</u>. The budget allocates \$18 million to CFPUA for drinking water extensions "to unserved communities in New Hanover County impacted by PFAS." This funding will allow CFPUA to advance an ongoing project in partnership with New Hanover County to connect residents currently on private groundwater wells to CFPUA services.

CFPUA also received \$17 million to support regional water and sewer system consolidations. For the past year, CFPUA and the Town of Wrightsville Beach have been exploring the possibility of a system consolidation. If that agreement is approved, this funding would support that effort.

CFPUA appreciates the work of New Hanover County's legislative delegation on behalf of our customers.

#### **Southside Replacement takes first step**



CFPUA's largest ever capital project is officially underway.

This month, the CFPUA Board voted to award a \$13,067,660 contract to Crowder Construction Company for Phase 1 Services for the Southside Wastewater Treatment Plant Replacement and Upgrade Project.

The project will fully replace CFPUA's Southside Plant, which was constructed in 1972. The project will also expand its treatment capacity from 12 million gallons per day (MGD) to 16 MGD.

Phase 1 services for the design-build project includes an engineering report, site survey, 75 percent design specifications and drawings, permits acquisition,

and other pre-construction work. The \$13 million value of Phase 1 is approximately 5.4 percent of the project's budget of \$240 million.

Phase 1 is expected to be completed by July 2025, with construction on the full project expected to be completed by the start of 2030.

Design-build is a type of project management in which the owner, in this case CFPUA, selects a single team to perform both project design and construction. Historically, design-build expedites and simplifies the delivery of a completed project.

CFPUA has also received a \$35 million low-interest loan from the N.C. Department of Environmental Quality (NCDEQ) Division of Water Infrastructure for the project. This low-interest loan (1.76 percent) from the Clean Water State Revolving Fund will lower the overall amount CFPUA will have to borrow for this project and could reduce the project's impact on the rates CFPUA customers pay for service.

### **Grant helps with water line replacements**



The N.C. Department of Environmental Quality this month awarded funding to 30 communities for projects to find and replace water service lines potentially containing lead. CFPUA received the highest award at \$4,161,150.

The U.S. Environmental Protection Agency (EPA) requires every water utility in the country to survey water service lines as part of its updated <u>Lead and Copper Rule</u>, which sets regulations for lead and copper in drinking water.

To date, CFPUA has surveyed 10,500 properties in our service area. While crews have found zero lead water lines, approximately 500 were older, galvanized lines, many of which include a 2-foot section of lead pipe called a gooseneck that connects the water service line to the water main. CFPUA will use this funding to replace those lines.
