Changes Coming to City of Wilmington Trash Service

If you live within Wilmington City limits, City solid waste charges likely appear on your monthly CFPUA bill. While CFPUA handles billing for the City's trash services, as well as City stormwater, trash operations are managed by the City.

Starting September 23, our partners at the City of Wilmington are rolling out new automated trash trucks. Some customers will see their trash and recycling pick-up day change as part of the rollout.

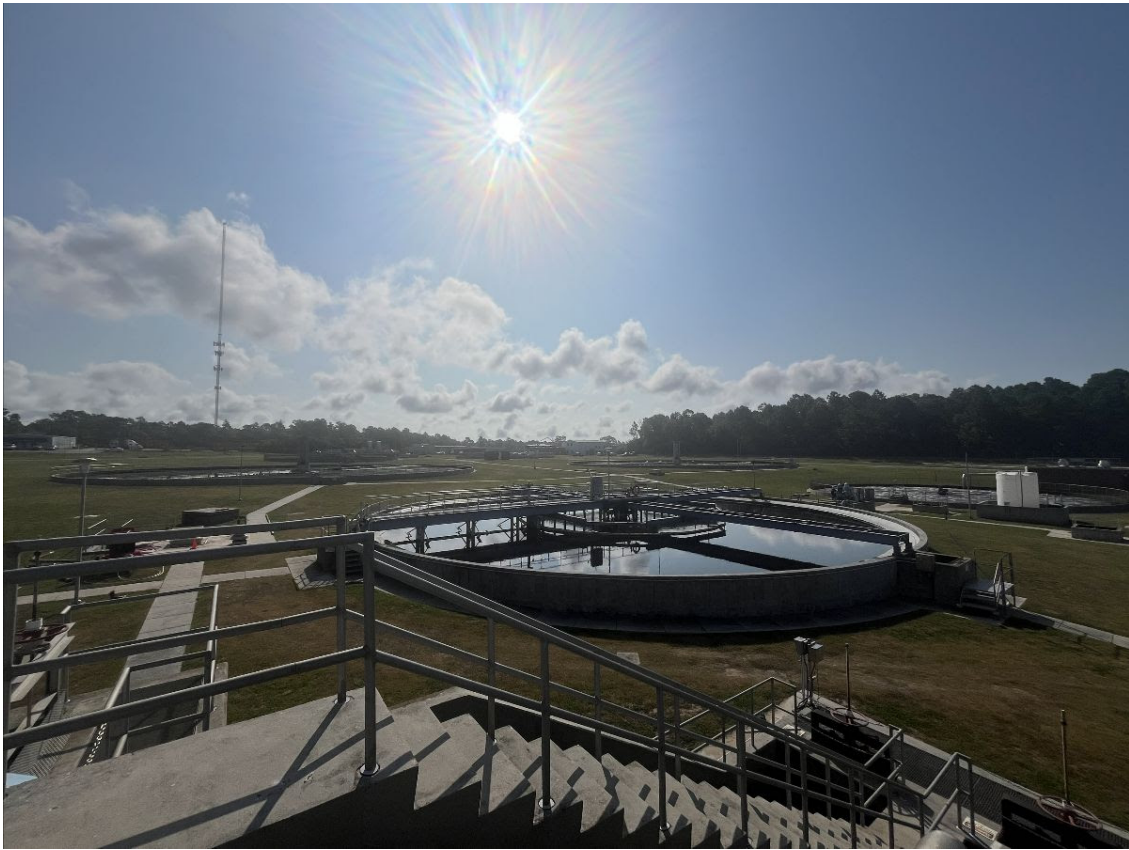
